## (I) Eligibility Criteria:-

Re-E-Tender is invited from bona-fide Manufacturers / Re-packer / FPO / FPC, who meet the following criteria & specifications:-

- The bidder must have minimum 3 (three) years experience of similar kinds of work of Printing of packet, Packaging and Supply of Mustard Oil. They should submit documentary evidence in support of that.
- 2. The bidder should have required infrastructure / facilities for production, Printing of packaging materials as per the supplied design (in open file), packaging of product in 1 (one) Ltr poly-pouch packets and storing of Raw / Final Products and transportation of the Packaged products up to the designated storage point at Khadya Bhavan, 11 A, Mirza Ghalib Street, Kolkata 700087 or as per the direction of the authority in WBECSC Ltd.
- The bidder should upload the copy of the Balance sheet with an annual turnover in similar kinds of work not less than 50 (fifty) lakh / year for last three financial years (2018-19, 2019-20 and 2020-21), duly audited by Chartered Accountant.
- The bidder should upload the copy of Income Tax Return for last 3 financial years (2018-19, 2019-20 and 2020-21) duly self attested.
- 5. The GST registration number/Copy of GSTIN Acknowledgement letter of bidder must be submitted by each bidder and HSN code specially related to Mustard Oil business must also be mentioned.
- 6. The bidder must have capacity to supply at least 50,000 liter Mustard Oil at a time throughout West Bengal. Documentary evidence of supply with quantity should be submitted.
- The bidder should submit documentary evidences i.e. Transaction ID / UTR Number of NEFT / RTGS receipt for deposit of EMD.
- 8. The Bidder should submit valid license (FSSAI and other required license) for supplying of Mustard Oil from the competent authority.

## **Specifications**

Mustard Oil and Poly-Pouch Packet must conform to the standard as per specification of Mustard Oil and Poly-Pouch Packet for Packaging of Mustard Oil as laid down in "The Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011".

(II) Instruction to tenderers for appointment as supplier of Mustard Oil within predesigned sealed 1 liter poly-pouch packets (includes printing and packaging):-

- i) Supplied Mustard Oil and poly-pouch must be of Standard quality and compliant to the above mentioned specification.
- ii) Supplier must have facilities to test the quality of Mustard Oil in their processing units /at their godowns.

iii) The Mustard Oil shall be manufactured in premises maintained in a hygienic condition which shall be open to inspection at any time.

iv) Supplier should submit 4 (four) ready to supply samples to the office of the undersigned before starting of supply for quality testing.

v) Finished Mustard Oil poly-pouch packet should be transported up to the designated storage point at Khadya Bhavan, 11 - A, Mirza Ghalib Street, Kolkata - 700087 or as per the direction of the authority in WBECSC Ltd.

## (III) Terms and Conditions

### 1. Submission of Re-E-Tender:

- I. All appendices, attached with this Re-E-Tender Document should be duly filled in and uploaded with digital signature in all pages. This is mandatory for considering any offer as valid.
- II. Bidder must complete the questionnaires on standard proforma enclosed (Appendix-1 to 6) with this Re-E-Tender Document.
- III. The Re-E-Tender Committee reserves the right to get the processing / packaging capacity of any bidder re-verified through the inspecting agencies / Officials of WBECSC Ltd., irrespective of their registration status.
- IV. Re-E-Tenders are to be submitted online in the website in the specified folder one for Technical Details and another for Financial.
- V. All appendices attached with this Re-E-Tender Document should be duly filled in with signature in all pages and are mandatory for considering any offer as valid.
- VI. The Re-E-Tenders of those who do not qualify the eligibility criteria shall be rejected at any time during detailed scrutiny and evaluation stage.
- VII. Re-E-Tender form downloaded in the name of the prospective bidder / firm alone should be used otherwise it will be rejected.
- VIII. Conditional offer will summarily be rejected.

## 2. Deposition Of Fees:

- a) The Bidders should furnish an Earnest money of Rs 52,800.00 (Rupees fifty two thousand eight hundred) only and that should be deposited through online E-Tender portal by 05.04.2023 at 12:00 noon.
- b) Successful bidder should deposit Rs. 79,200.00 (Rupees seventy nine thousand and two hundred) only as security deposit which will be kept till completion of work.
- c) The security deposit shall not carry any interest.

#### 3. Registration of Bidder:

Bidders willing to take part in the process of **e-tendering** will have to be enrolled & registered with the Government e-Procurement system through logging on to website *www.wbtenders.gov.in* and to click on the link for e-tendering site as given on the web portal.

#### 4. Digital Signature Certificate (DSC):

Each participant, for submission of Re-E-Tender, is required to obtain a Class - II or Class - III Digital Signature Certificate (DSC) from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount the details of which are available at the Web Site Guideline to the Bidder. DSC is given as a USB e-Token.

#### 5. Downloading:

Bidders can download NIT & Re-E-Tender Documents through log in into the website mentioned using the Digital Signature Certificate. This is the only mode of collection of Re-E-Tender Documents.

#### 6. Pre Bid Meeting:

Prospective bidders in the Re-E-Tender may attend a Pre-Bid Meeting which will be held on **28.03.2023 at 12:00** noon at our Head Office at 11-A, Mirza Ghalib Street, Kolkata -700087 for any type of clarification regarding Re-E-Tender.

#### 7. Financial Bid :

The Financial Bids of only Technically Qualified Bidders shall be opened.

#### 8. Transport Facility:

The bidder should have sufficient fleet of trucks, owned / or contractual to ensure door-step delivery at distribution point.

#### 9. Validity of Offer :

- a) The offers made by the bidders will be valid for 365 (three hundred and sixty five) days from the date of acceptance of offer.
- b) The entire quantity of work order has to be delivered within the specified time.
- c) The bidder should not quote any other date for validity of the offer.
- d) Tenderers quoting any other validity date are liable to be summarily rejected.

e) The validity of the offer may be extended if deemed necessary by the relevant authority.

The management is not responsible for any upward revision of any taxes or raw materials after issue of the confirmed orders and the extra amount, if any incurred towards the packaging materials will be borne only by the successful bidder. Entire GST liability lies on the successful bidder for the packaging materials.

#### 10. Agreement:

The successful bidder shall execute an Agreement in the prescribed form on a stamp paper of Rs. 100.00 (rupees one hundred) only after depositing the Security Amount, within three days from the date of receipt of the communication of acceptance of the Re-E-Tender. In the event of failure to execute the agreement, the earnest money deposit shall be forfeited. In addition, the bidder will be treated as having committed breach of contract and will be liable to pay damages to the WBECSC Ltd. for such breach of contract besides black listing the firm. Further WBECSC Ltd. reserves the right to collect the consequential loss, if any sustained by them on account of re-tender from the bidder and the bidder is bound to pay the same on demand.

#### 11. Quality Control:

The supplier is solely responsible for the quality of Mustard Oil to be supplied by them. Before commencing delivery, the supplier should submit the analysis report made by any reputed laboratory approved by the Govt. of West Bengal or Govt. of India or FSSAI at their own cost.

#### 12. Scope of Work:

- (i) Supply of finished packaged product of Mustard Oil in 1 (one) Ltr poly-pouch packets under the brand name of WBECSC Ltd. duly packed in predesigned packaging material. Design of packaging which will be provided by the WBECSC Ltd.
- (ii) Supplied Mustard Oil must be of Standard quality and compliant to the prescribed FSSAI specification.
- (iii) Supplier must have facilities to test the quality of Mustard Oil in their processing units /at their godowns.

- (iv) Supplier should have capacity to supply Mustard Oil in 1 Ltr sealed poly-pouch packets as per specification mentioned above.
- (v) The Mustard Oil shall be manufactured in premises maintained in a hygienic condition which shall be open to inspection at any time
- (vi) The responsibility of supplier will be -
  - 1. To print the provided design on both side of 1 (one) Ltr size packet.

2. The selected supplier should maintain the design of packet which will be provided by the WBECSC Ltd. and the supplier should supply the material under the prescribed brand and logo of WBECSC Ltd.

3. To fill the poly-pouch packets with Mustard Oil maintaining proper quality, quantity and others standard packaging norms and relevant FSSAI regulations.

4. Poly-pouch packet of Mustard Oil must be supplied as per above mentioned fssai norms.

5. Finished Mustard Oil packet should be transported up to the designated storage point at Khadya Bhavan, 11 - A, Mirza Ghalib Street, Kolkata - 700087 or as per the direction of the authority in WBECSC Ltd.

## 13. Financial Evaluation :

- A. Financial bid of only technically qualified bidders shall be opened.
- B. Bidders shall quote their commercial bid (inclusive of all cost and all applicable taxes) within the maximum bid price assigned for the instant purpose. Any quoted rate equal or above the base price of the bidders shall not be considered for acceptance.
- C. Prospective bidders who have qualified for the desired technical specification and quoted lowest commercial bid will be selected.

#### 14. Applicability of Law :

This Re-E-Tender Document shall be governed and construed in accordance with the laws of India and shall be within the exclusive jurisdiction of the Courts at Kolkata only.

#### 15. Arbitration :

In the event of any disputes arising between the parties any of the parties aggrieved may refer the said dispute to the Managing Director of the First party seeking for arbitration and after having such a presentation from the aggrieved party, the Managing Director of the First party will appoint a sole arbitrator to settle the disputes according to the Arbitration and Conciliation Act, 1996 and the Award so passed by the Ld. Arbitrator will be binding upon both the parties.

#### 16. Penalty on Default/ Extension of Time:

- A. Failure to keep up the supply schedule, a penalty of minimum of Rs. 10/- per day per packet for the defaulted quantity may be levied for every day of delay in supply up to the date of actual supply.
- B. If any deviation from approved quality is found in sample testing during, the supply will immediately be suspended and the supplier will be blacklisted for future supply.
- C. The bidders should submit documents regarding production capacity per day in their official letter head apart from mentioning the same in **Appendix-4**.
- D. The firms / companies / suppliers who have been blacklisted by any government organization / Govt. PSU or a process of blacklisting is pending against them, are debarred from participating in the Re-E-Tender process.
- E. Any supply beyond valid indented period will be treated as illegal and penal action shall be initiated against the supplier which may include blacklisting.
- F. Only selected bidders will perform the job. No sub-bidder will be allowed to make any supply. If found, it will be viewed as violation of norms.
