(I) Eligibility Criteria:-

E-Tender is invited from bona-fide and competent Millers / Manufacturers / FPO / FPC, who meet the following criteria & specifications:-

- 1. The bidder must have minimum 2 (two) years experience in similar kinds of work. They should submit documentary evidence in support of that.
- 2. The bidder should upload the copy of the Balance sheet with an annual turnover in similar kinds of work not less than 50 (fifty) lakh / year for last three financial years (2018-19, 2019-20 and 2020-21), duly audited by Chartered Accountant.
- 3. The bidder should upload the copy of Income Tax Return for last 3 financial years (2018-19, 2019-20 and 2020-21) duly self attested.
- 4. The GST registration number/Copy of GSTIN Acknowledgement letter of bidder must be submitted by each bidder and HSN code specially related to Rice business must also be mentioned.
- 5. The bidder must have capacity to supply at least 50 MT food grain products like rice, cereals, pulses etc. at a time throughout West Bengal. Documentary evidence of supply with quantity should be submitted.
- 6. The bidder should submit documentary evidences i.e. ID Transaction / UTR Number of NEFT / RTGS receipt for deposit of EMD.
- 7. The Bidder should submit a valid license (FSSAI and other required license) for supplying food grain products from the competent authority.

Specifications

- Supplied Tulaipanji Rice should be as per Specification of -
- 1. The Department of Agriculture, Govt. of West Bengal.
- 2. FSSAI norms.

A) General characteristics:

- 1. Tulaipanji Rice shall be per boiled in nature and the processed of mature, dried, whole grains of Tulaipanji Paddy.
- 2. Tulaipanji Rice shall have reasonably uniform size, shape and color, characteristic of

- the variety / form.
- **3.** Tulaipanji Rice shall be clean, whole-some and free from moulds, weevils, obnoxious smell, discoloration, admixture of deleterious substance (including added coloring matter) and all other impurities except to the extent indicated under special characteristics.
- **4.** Tulaipanji Rice shall be in sound merchantable condition.
- **5.** Tulaipanji Rice shall not have moisture exceeding 14%.
- **6.** Tulaipanji Rice shall have good cooking quality.

C) <u>Definitions</u>:

- 1) "Foreign matter" includes dust, stones, lumps of earth, chaff, husk, stem, straw or any other impurity edible and non-edible seeds.
- 2) "Admixture" means any rice other than the principal rice.
- 3) "Damaged or discolored" are those rice that are internally damaged or discolored to such extent that such damage or discoloration materially affects the quality of the rice.
- 4) "Weevil led" are those rice that are partially or wholly bored or eaten by weevil or other grain insects.
- 5) "Broken" include pieces below ¾ and above ¼ of the full size splits.
- 6) "**Fragments**" include pieces below ½ of the full size splits.
- 7) "Partially husked splits and wholes (both husked and unhusked)" include:
 - 1. Pieces that are partially husked.

- 2. Wholes whether with husk or without husk.
- 8) "Slightly touched" are those rice that are superficially damaged or discolored such damaged or discoloration not materially affecting the quality of the rice.
- 9) "Red Grains" are those rice that are red in color.

(II) Instruction to tenderers for appointment as supplier of Tulaipanji Rice.

- Supplied Tulaipanji Rice must be of Standard quality and compliant to the above mentioned specification.
- ii) Supplier must have facilities to test the quality of Tulaipanji Rice in their processing units /at their godowns.
 - iii) The Tulaipanji Rice shall be manufactured in premises maintained in a hygienic condition which shall be open to inspection at any time.
 - iv) Supplier should submit 4 (four) ready to supply samples to the office of the undersigned before starting of supply for quality testing.
 - v) Finished Tulaipanji Rice packet should be transported up to the designated storage point at Khadya Bhavan, 11 A, Mirza Ghalib Street, Kolkata-700087 or as per the direction of the authority in WBECSC Ltd.

(III) Terms and Conditions

1. Submission of Tender:

- I. All appendices attached with this Tender Document should be duly filled in and uploaded with digital signature in all pages. This is mandatory for considering any offer as valid.
- II. Bidders must complete the questionnaires on standard proforma enclosed (Appendix-1 to 6) with this Tender Document.
- III. The Tender Committee reserves the right to get the processing / packaging capacity of any bidder re-verified through the inspecting agencies/ Officials of WBECSC Ltd, irrespective of their registration status.
- IV. Tenders are to be submitted online in the website in the specified folder one for Technical Details and another for Financial.
- V. All appendices attached with this Tender Document should be duly filled in with signature in all pages and are mandatory for considering any offer as valid.
- VI. The tenders of those who do not qualify the eligibility criteria shall be rejected at any time during detailed scrutiny and evaluation stage.
- VII. Tender form downloaded in the name of the prospective bidder / firm / organization alone should be used otherwise it will be rejected.
- VIII. Conditional offer will summarily be rejected.

2. Deposition Of Fees:

- a) The Bidders should furnish an Earnest money of **Rs 44,000.00 (Rupees forty four thousand) only** and that should be deposited through online E-Tender portal by **01.02.2023 at 12:00 noon**.
- b) Successful bidder should deposit **Rs. 66,000.00 (Rupees sixty six thousand) only** as security deposit which will be kept till completion of work.
- c) The security deposit shall not carry any interest.

3. Registration of Bidder:

Bidders willing to take part in the process of **e-tendering** will have to be enrolled & registered with the Government e-Procurement system through logging on to website

www.wbtenders.gov.in and to click on the link for e-tendering site as given on the web portal.

4. Digital Signature Certificate (DSC):

Each participant, for submission of tender, is required to obtain a Class - II or Class - III Digital Signature Certificate (DSC) from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount the details of which are available at the Web Site Guideline to the Bidder. DSC is given as a USB e-Token.

Downloading:

Bidders can download NIT & Tender Documents through log in into the website mentioned using the Digital Signature Certificate. **This is the only mode of collection of Tender Documents**.

6. Pre Bid Meeting:

Prospective bidders in the tender may attend a Pre-Bid Meeting which will be held on **30.01.2023 at 12:00** noon at our Head Office at 11-A, Mirza Ghalib Street, Kolkata - 700087 for any type of clarification regarding Tender.

7. Financial Bid:

The Financial Bids of only Technically Qualified Bidders shall be opened.

8. Transport Facility:

The bidder should have a sufficient fleet of trucks, owned/ or contractual to ensure door-step delivery at distribution point.

9. Validity of Offer:

- a) The offers made by the bidders will be valid for 365 (three hundred and sixty five) days from the date of acceptance of offer.
- b) The entire quantity of work order has to be delivered within the specified time.
- c) The bidder should not quote any other date for validity of the offer.
- d) Tenderer quoting any other validity date are liable to be summarily rejected.
- e) The validity of the offer may be extended if deemed necessary by the relevant authority.

The management is not responsible for any upward revision of any taxes or raw materials after issue of the confirmed orders and the extra amount, if any incurred towards the packaging materials will be borne only by the successful bidder. Entire GST liability lies on the successful bidder for the packaging materials.

10. Agreement:

The successful bidder shall execute an Agreement in the prescribed form on a stamp paper of Rs. 100.00 (rupees one hundred) only after depositing the Security Amount, within three days from the date of receipt of the communication of acceptance of the Tender. In the event of failure to execute the agreement, the earnest money deposit shall be forfeited. In addition, the bidder will be treated as having committed breach of contract and will be liable to pay damages to the WBECSC Ltd. for such breach of contract besides black listing the firm. Further WBECSC Ltd. reserves the right to collect the consequential loss, if any, sustained by them on account of re-tender from the bidder and the bidder is bound to pay the same on demand.

11. Quality Control:

The supplier is solely responsible for the quality of Tulaipanji Rice to be supplied by them. Before commencing delivery, the supplier should submit the analysis report made by any reputed laboratory approved by the Govt. of West Bengal or Govt. of India or FSSAI at their own cost.

12. Scope of Work:

- 1) Supplied Tulaipanji Rice must be of Standard quality and compliant to the above mentioned specification.
- 2) Supplier must have facilities to test the quality of Tulaipanji Rice in their processing units /at their godowns.
- 3) The Tulaipanji Rice shall be manufactured in premises maintained in a hygienic condition which shall be open to inspection at any time.
- 4) Ready Tulaipanji Rice bag should be transported up to the designated storage point at Khadya Bhavan, 11 A, Mirza Ghalib Street, Kolkata-700087 or as per the direction of the authority in WBECSC Ltd.

13. Financial Evaluation:

- A. Financial bid of only technically qualified bidders shall be opened.
- B. Bidders shall quote their commercial bid (inclusive of all cost and exclusive of all applicable taxes) within the base price assigned for the instant purpose. Any quoted rate equal or above the base price of the bidders shall not be considered for acceptance.
- C. Prospective bidders who have qualified for the desired technical specification and quoted lowest commercial bid will be selected.

14. Applicability of Laws:

This E-Tender Document shall be governed and construed in accordance with the laws of India and shall be within the exclusive jurisdiction of the Courts at Kolkata only.

15. Arbitration:

In the event of any disputes arising between the parties any of the parties aggrieved may refer the said dispute to the Managing Director of the First party seeking for arbitration and after having such a presentation from the aggrieved party, the Managing Director of the First party will appoint a sole arbitrator to settle the disputes according to the Arbitration and Conciliation Act, 1996 and the Award so passed by the Ld. Arbitrator will be binding upon both the parties.

16. Penalty on Default / Extension of Time:

- A. Failure to keep up the supply schedule, a penalty of minimum of Rs. 10/- per day per Kg for the defaulted quantity may be levied for every day of delay in supply up to the date of actual supply.
- B. If any deviation from approved quality is found in sample testing during, the supply will immediately be suspended and the supplier will be blacklisted for future supply.
- C. The bidders should submit documents regarding production capacity per day in their official letter head apart from mentioning the same in **Appendix-4**.
- D. The firms / companies / suppliers / organization who have been blacklisted by

any government organization / Govt. PSU or a process of blacklisting is pending against them, are debarred from participating in the tender process.

- E. Any supply beyond valid indented period will be treated as illegal and penal action shall be initiated against the supplier which may include blacklisting.
- F. Only selected bidders will perform the job. No sub-bidder will be allowed to make any supply. If found, it will be viewed as violation of norms.
